At Victory Online Academy (VOA), strong communication between the school, students, and families is essential for student success. This agreement outlines the expectations and responsibilities for maintaining consistent, timely, and effective communication in an online learning environment.

Official Communication Platforms

VOA uses the following platforms as the **official methods of communication**. Parents/guardians and students are expected to regularly monitor these:

- Student Email Accounts
- PowerSchool Parent Portal
- School Status Connect
- School Messenger (phone calls, voice messages, text messages, and emails)
- Canvas Parent App
- Canvas Student App
- YouTube
- Monthly newsletters (via Smore)
- Official VOA social media platforms (Facebook, Instagram, TikTok, and X)

These platforms serve as the **primary sources of school communication**.

Parent/Guardian Contact Information

- Parents/guardians must provide **accurate and up-to-date contact information** at the time of enrollment.
- Any changes to contact information must be reported to VOA immediately.
- VOA will rely on the contact information on file for all communication.
- VOA is **not responsible for missed communications** due to outdated or incorrect contact information.

Consent to Receive Communications

By enrolling in VOA, parents/guardians and students agree to receive communication through the official platforms listed above, including:

- Emails
- Phone calls (including voice messages)
- Text messages

These communications may include, but are not limited to:

- Academic updates and progress reports
- Attendance notifications
- Behavior and wellness updates
- School announcements and reminders

- Emergency notifications

Standard message and data rates may apply based on your mobile service provider.

Parent/Guardian & Student Responsibilities

To support student success, parents/guardians **and students** agree to:

- Regularly check email, phone messages, and text messages
- Log into PowerSchool to monitor grades and attendance
- Access and engage in coursework through Canvas
- Review school newsletters and updates
- Respond to school communication in a timely manner when needed

Social Media Use

VOA may share announcements, highlights, and general updates on official social media platforms. Social media is a **supplemental tool** and should not replace official communication channels.
